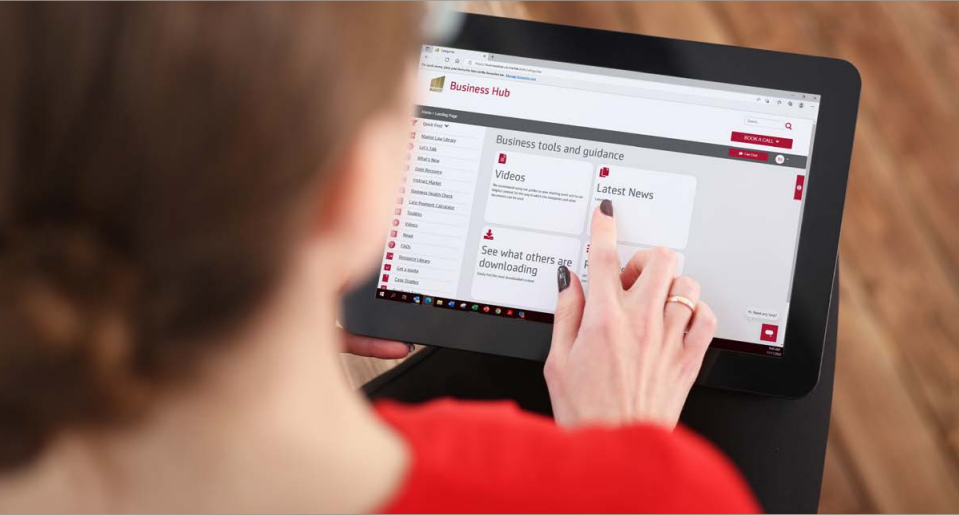

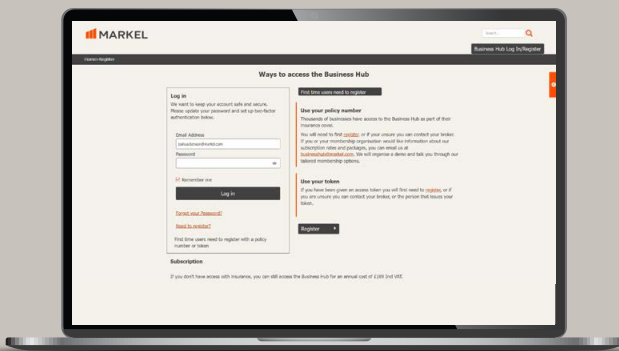

In order to access the Business Hub, you will need to follow the guidance in your policy management information. Or follow these simple steps:

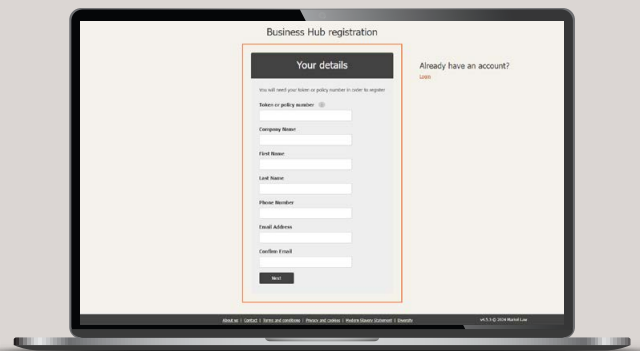
## Step 1

Visit [businesshub.uk.markel.com](https://businesshub.uk.markel.com)  
Click on the 'Register' button.



## Step 2

Enter your details in the [registration form](#). When entering your token or policy number, as stated in your policy management information, remember that this is case sensitive.



## Step 3

We'll send you an activation email that will lead you to set up your password and 2 factor authentication.

## Step 4

Choose between setting up an email or SMS authentication to keep your account secure. Then you are ready to go!
